

Manion WOD Peer-to-Peer Fundraising Incentive Contest – Official Rules

1. Sponsor

This incentive contest (“Contest”) is organized and administered by Travis Manion Foundation (“Sponsor”) in connection with the Manion WOD fundraising campaign.

2. Prize Provider

Prizes for this Contest have been generously donated by Major Fitness (“Prize Provider”). The Prize Provider is not responsible for the administration of the Contest, the selection of winners, or compliance with applicable laws.

3. Eligibility

- Open to legal residents of the United States who are 18 years or older at the time of entry.
- Void where prohibited by law.
- Employees, officers, and directors of Sponsor are ineligible.
- Participants must register as individual peer-to-peer fundraisers through the official campaign platform.

4. Contest Period

- Start Date: March 1, 2026
- End Date: May 15, 2026

All donations must be received by the End Date to count toward totals.

5. How to Participate

- Register as a peer-to-peer fundraiser for the Manion WOD campaign.
- Solicit donations in support of the campaign.
- To ensure proper credit toward an individual participant’s fundraising total, all donations must be made through that participant’s unique fundraising page and corresponding URL. Donations submitted through any other method or page will not be credited toward a participant’s total for purposes of this contest. Sponsor shall have no obligation or ability to track, reassign, transfer, or refund donations that are submitted incorrectly or outside of a participant’s designated fundraising page.
- Donations must be completed and successfully processed within the Contest Period.

No purchase or donation is required to participate as a peer-to-peer fundraiser.

Participation is free; fundraising activity is voluntary.

6. Winner Determination & Minimum Threshold

- Winners will be determined based on the **total amount of eligible funds raised** during the Contest Period.
- All donations must be made and successfully processed through the official peer-to-peer fundraising platform. To be credited toward an individual participant’s fundraising total,

donations must be submitted through that participant's unique fundraising page and corresponding URL. Donation checks are also accepted with a note in the subject line of the participants name and reference of "Manion WOD 2026".

- Rankings will be based on **net donations received** (excluding refunded, fraudulent, or disputed transactions).

Minimum Qualification Requirement:

- To be eligible to receive any prize, a participant must raise a minimum of **\$500** during the Contest Period.
- If fewer than three participants meet the minimum threshold, only those who qualify will be awarded prizes, in rank order.
- Sponsor reserves the right not to award any prize if the minimum threshold is not met.

Prizes:

- **1st Place (ARV: \$4,199.99):** Heritage Series B17 Flying Fortress All-In-One Functional Trainer with Smith Machine
- **2nd Place (ARV: \$2,999.99):** B52 All-In-One Home Gym Smith Machine
- **3rd Place (ARV: \$1,999.99):** F22 All-In-One Home Gym Power Rack

In the event of a tie, the participant who reached the tied fundraising total first will receive the higher ranking.

7. Prize Conditions

- Prizes are non-transferable and non-assignable, and no substitutions shall be permitted except at the sole discretion of the Sponsor. Sponsor reserves the right to substitute any prize with another of equal or greater value.
- Winners shall be solely responsible for the assembly and installation of all awarded equipment. Assembly is not included unless expressly stated in writing by the Sponsor.
- In the event the awarded equipment requires scheduled delivery, winners shall be solely responsible for coordinating delivery arrangements with the designated shipping provider and Major Fitness, including, without limitation, scheduling, site access, and availability.
- Each winner must respond to the Sponsor's notification within fifteen (15) days and provide all information reasonably requested by the Sponsor to facilitate prize fulfillment. Failure to respond within such fifteen (15)-day period shall result in forfeiture of the prize without further notice. In such event, the prize may be awarded to the next highest eligible fundraiser, who shall be subject to the same response requirements and timeframe.
- Winners shall be responsible for all costs and expenses not expressly stated herein, including, without limitation, costs associated with assembly, installation, delivery coordination, and any applicable federal, state, or local taxes. Sponsor reserves the right, in its sole discretion, to offer an alternative prize.

8. Tax and Reporting Obligations

- Prizes are considered **taxable income**.

- Winners will be required to complete a W-9 form.
- Sponsor will issue an IRS Form 1099-MISC where required, in accordance with the Internal Revenue Service.
- Winners are solely responsible for all federal, state, and local taxes.

9. Publicity Release

By accepting a prize, winners agree to allow Sponsor to use their name, likeness, and fundraising story for promotional purposes without additional compensation, unless prohibited by law.

10. General Conditions

- Sponsor reserves the right to disqualify any participant who tampers with the process or violates these Official Rules.
- Donations obtained through fraudulent or unethical means will be disqualified.
- Sponsor reserves the right to cancel, suspend, or modify the Contest if necessary.

11. Limitation of Liability

Sponsor is not responsible for technical failures, transaction errors, or any injury or damage resulting from participation or prize use.

12. Compliance with Laws

This Contest is intended to comply with all applicable laws, including those of the state of California. This is a skill-based incentive program and does not constitute a raffle, lottery, or game of chance.
